Neurodevelopmental Assessment of Children in Low Resourced Settings, Principal Investigator (PI)
 Funded by the Eunice Kennedy Shriver National Institute of Child Health and Human Development (NICHD) at \$985k this project addresses gaps in the research and practice of developmental assessments of young children from culturally diverse groups, living in poverty, and exposed to multiple adverse childhood experiences, including homelessness. Under this Fast Track study, we are developing and validating a neurodevelopmental assessment instrument to assess child development, in context.
